

ACKNOWLEDGMENT AND ASSUMPTION OF RISK

THIS DOCUMENT PERTAINS TO YOUR LEGAL RIGHTS IN CASE OF INJURY. READ ALL OF THE TERMS CAREFULLY BEFORE SIGNING.

IT IS THE PURPOSE OF THIS ACKNOWLEDGMENT AND ASSUMPTION OF RISK (THE "ACKNOWLEDGMENT") FOR THE PARTICIPANT (AND PARTICIPANT'S PARENT(S)/GUARDIAN(S), IF APPLICABLE) TO ACKNOWLEDGE THAT PARTICIPATION IN ICE HOCKEY IS DANGEROUS AND MAY RESULT IN SEVERE INJURY. BY SIGNING THE ACKNOWLEDGMENT, THE PARTICIPANT CONFIRMS HIS OR HER KNOWLEDGE THE RISKS ASSOCIATED WITH PLAYING ICE HOCKEY.

"WYHA" includes Waunakee Youth Hockey Association, Inc., d/b/a Wildcat Youth Hockey Association, its officer and directors, member teams, event hosts, other participants, coaches, officials, sponsors, and volunteers.

For and in consideration of the undersigned Participant being allowed to participate in WYHA events and member team activities, Participant (and the parent(s) or legal guardian(s) of Participant, if applicable) acknowledges, understands and assumes risk relating to ice hockey and any member team activities, and understands that ice hockey and member team activities involve risks to Participant's person including bodily injury, partial or total disability, paralysis and death, and damages which may arise therefrom and that the Participant (and the parent(s) or legal guardian(s) of Participant, if applicable) has full knowledge of said risks. These risks and dangers may be caused by the negligence of the Participant or the negligence of others, including WYHA. These risks and dangers include, but are not limited to, those arising from participating with bigger, faster and stronger participants, and these risks and dangers will increase if Participant participates in ice hockey and member team activities in an age group above that which Participant would normally participate in. Participant (and Participant's parent(s)/guardian(s), if applicable) further acknowledges that there may be risks and dangers not known or not reasonably foreseeable at this time. Participant (and participant's parent(s)/guardian(s), if applicable) acknowledges, understands and assumes the risks, if any, arising from the conditions and use of ice hockey rinks and related premises.

As a condition of participation in WYHA events and member team activities, Participant (and Participant's parent(s)/guardian(s), if applicable) agrees to abide by and be bound under the playing rules and rules and regulations of USA Hockey, including the By-Laws of USA Hockey, and WYHA's policies and codes of conduct.

This Acknowledgment affects your legal rights, and you may wish to consult an attorney concerning your legal rights. Participant (and Participant's parent(s)/guardian(s), if applicable) acknowledges that he or she has been provided and has read the above paragraphs, that he or she is fully advised of the potential dangers of ice hockey, that he or she signs this document voluntarily, understanding that this Acknowledgment is necessary to allow amateur ice hockey to exist in its present form.
